1. Consultation Methodology

1.1 Purpose of the Consultation

The consultation was conducted to meet statutory requirements for the Significant Change Application (Tier 1) submitted by Wells Park School, as part of The Beckmead Trust. It aimed to gather feedback on the proposal to increase pupil capacity at Wells Park School, a specialist residential provision which serves children aged 5 – 11 with Social, Emotional and Mental Health (SEMH) needs. The school is currently over-subscribed, and the proposed expansion would raise its capacity from 56 to 70 pupils, including an increase in residential places from 40 to 51. This increase in residential places reflects the continued need for safe, nurturing, and structured residential support for some of the most vulnerable children in Essex. The proposed change, supported by the LA, also responds to a growing demand for SEMH provision in Essex, and aims to reduce reliance on out-of-county placements by expanding access to high-quality local services. The consultation period ran from April 28th to May 19th, 2025, to provide additional information, answer questions, and gather more detailed feedback from stakeholders.

1.2 Consultation Timeline

The consultation was conducted over a three-week period, commencing at 12:00pm on Monday, 28th April 2025, and concluding at 12:00pm on Monday, 19th May 2025. This timeline met the minimum statutory requirement of three weeks, allowing sufficient time for stakeholder participation.

1.3 Stakeholders Engaged

The consultation aimed to involve a range of stakeholders relevant to the proposed changes. These included:

- Parents and carers of current and prospective students.
- Local authority representatives from Essex and bordering areas.
- Staff members of Wells Park School.
- Members of the local community.
- Representatives from local housing developments.
- Primary and secondary schools within Essex and neighbouring areas.

- Health and leisure centres.
- Daycare providers.
- Community centres.
- Other educational and learning institutions, such as public libraries.

Stakeholders were selected to ensure a comprehensive understanding of the proposal's impact on educational provision, operational logistics, and community relations. Full details on the stakeholders engaged, including the stakeholder map, are given in Annex 6.

1.4 Methods of Engagement

A consultation survey was the primary method of engagement. The survey was designed to capture both quantitative and qualitative feedback, allowing respondents to express their level of support for the proposal through Yes/No responses and provide additional comments on specific aspects of the plan.

Initial Notification

To commence the stakeholder engagement, the email noted in Annex 2 was sent out to all stakeholders listed in Annex 5, and the emails noted in Annexes 3 and 4 were sent to those corresponding stakeholders.

Survey Design

The survey included seven key questions addressing themes such as support for the capacity increase, local need for additional primary-aged SEMH places in Essex, and the expansion's impact on children and families who require this type of provision. The questions used in the survey are given in Annex 1.

Survey Distribution

The survey was made available online from 12:00pm on Monday, 28th April 2025, and concluded at 12:00pm on Monday, 19th May 2025.

Consultation Session

In addition to the survey, a virtual consultation session was advertised for 7th May 2025 to provide stakeholders with an opportunity to engage in real-time discussions about the proposed changes. Invitations were shared via email and published on both the school's and trust's website to encourage broad participation. However, there were no attendees at the event, which suggests that stakeholders did not have strong objections or pressing concerns that required discussion in a live forum.

1.5 Information Provided

Stakeholders were provided with detailed information about and asked whether they supported the proposed changes, including the capacity increase, local need for additional primary-aged SEMH places in Essex, and the expansion's impact on children and families who require this type of provision. These materials were distributed digitally and made accessible through the school's and trust's website and targeted communications. Respondents were encouraged to review this information to inform their feedback.

2. Consultation Feedback

2.1 Overview of Responses

The consultation process gathered feedback through a three-week survey and a virtual consultation event. A total of 6 survey responses were received, offering both quantitative and qualitative data. Respondents all self-identified as parents/carers or family members of a child attending Wells Park School. The virtual consultation session, advertised for 7th May 2025, would have provided an additional forum for stakeholders to discuss the proposal in real-time. The limited uptake for this, combined with the overall positivity of responses, suggests that stakeholders did not have strong objections or pressing concerns that required discussion in a live forum.

2.2 Key Themes Identified

1. Support for the proposed capacity increase

- 83% (5 of 6) of survey respondents supported the proposal to increase the capacity at Wells Park School from 56 to 70 pupils, including 11 residential placements. The remaining 17% (1 of 6) responded "I don't know".
- Key reasons for support included:
 - Recognition of Wells Park's reputation as providing a focus on child wellbeing and emotional health.
 - Increasing the number of children getting the appropriate support and opportunities they need.
- Concerns included one comment regarding the increase of group sizes with the increase in capacity. Outlining that their child deregulates in large groups and a larger class size could mean more deregulations.

2. Demand for additional primary-aged SEMH places in Essex

 83% of respondents felt that there was a local need for additional primary-aged SEMH places in Essex. The increased demand was noted with no concerns raised. The remaining 17% responded with "I don't know".

3. Proposed expansion's impact on children and families who require SEMH provision

- 100% of respondents answered that expanding Wells Park School will have a positive impact on children and families who require this type of provision.
- Feedback noted the reputation of the school and its supportive nature, including comments regarding the positive impact Wells Park School has had.

2.3 Feedback from the Consultation Event

The virtual consultation session, advertised for 7th May 2025, would have provided an additional forum for stakeholders to discuss the proposal in real-time. The limited uptake for this suggests that stakeholders did not have strong objections or pressing concerns that required discussion in a live forum.

2.4 Stakeholder Concerns

1. Increased class sizes

 One respondent noted that an increase in school capacity would have an impact on class sizes. An increase in class sizes could cause pupils to become dysregulated, countering the progress made so far at Wells Park.

2.5 Positive Feedback

Despite this concern, there was an overwhelming strong support for the proposal, particularly the ability to offer more places to children and families who need it most. Stakeholders recognised the potential of these changes to enhance the educational opportunities available to vulnerable children and address growing demand for SEMH primary education in Essex.

This feedback has guided the development of mitigation strategies, ensuring the proposed change is implemented effectively and equitably.

3. Mitigations for Concerns

3.1 Overview of Mitigation Approach

The consultation process identified one area of concern among stakeholders, an increase in class sizes. Mitigation strategies have been designed to address this concerns proactively, ensuring the successful implementation of the proposed expansion while maintaining the quality of provision.

3.2 Mitigations by Questions

Issue and Question Number	Area of concern	Reflection and Mitigation
Q2: In providing additional comments regarding Q1, one responded expressed concerns about increased class sizes and the negative impact it could have on existing pupils.	Increase in class sizes due to an increase in capacity could destress pupils who do not do well in large settings. In extreme cases, this could result in emotional dysregulation or regression in their developmental progress.	The concern raised about the potential negative impact of increased class sizes is both valid and important. For pupils with SEMH needs, the learning environment plays a critical role in their ability to thrive. Larger class sizes could indeed lead to increased levels of stress for some children, particularly those who struggle in overstimulating or less structured group settings. These are precisely the types of outcomes that Wells Park School is committed to avoiding. To mitigate this concern, the school will not simply increase capacity without careful planning around staffing, space, and structure. The increase in pupil numbers will be matched by a proportional increase in staffing levels to maintain low pupil-to-adult ratios, which

are fundamental to the school's traumainformed and therapeutic approach.

The physical expansion supported by the council's capital funding will ensure that there is adequate space to accommodate more pupils without compromising the calm, structured environment that is essential for their development. Group sizes within classrooms and residential settings will continue to be carefully managed, and any changes will be introduced gradually with regular monitoring of pupil wellbeing and behaviour. These steps are designed to preserve the quality of care and education that Wells Park School is known for, even as it seeks to expand its capacity to meet a growing local need.

3.3 Ongoing monitoring and feedback

To ensure the success of the proposed changes and address stakeholder concerns over time, the following mechanisms will be implemented:

- Regular feedback sessions with staff and stakeholders to identify and resolve emerging issues.
- Monitoring and evaluation of operational efficiency and staff satisfaction, with adjustments made as required.
- Transparent communication with stakeholders to keep them informed about progress and outcomes.

These mitigations aim to address stakeholder concerns comprehensively while ensuring that Wells Park School can successfully implement its proposed expansion and maintain high standards of education and care for its pupils and their families.

4. Annex 1 – Survey Questions and Responses

Q1. Do you support the proposal to increase the capacity at Wells Park School from 56 to 70 pupils, including 11 residential placements?

This question aimed to gauge stakeholder support for the capacity expansion and its alignment with the school's mission to provide high-quality, trauma informed education to children requiring alternative provision.

Answer: Of the 6 respondents who completed this question, 83.3% (5 respondents) answered affirmatively, expressing a positive attitude towards the capacity expansion of Wells Park School, as part of The Beckmead Trust. 16.7% of those who completed this question (1 respondent) answered "I don't know".

Q2. Can you please briefly explain the reason for your answer to the previous question?

• This follow-up question provided qualitative insights into respondents' views, enabling a deeper understanding of their support or concerns regarding the increase in capacity.

Answer: This section allowed respondents to share additional comments to elaborate on their answers to the previous question, providing qualitative insights into their perspectives. Of the 6 respondents who completed this question, all provided explanations. The responses reflect overall supportive perspectives.

Comments included:

- "Wells Park is a brilliant school with a focus on the right things such as child wellbeing and emotional health and I wish mainstream schools were like Wells Park in that regard".
- "Daniel is getting a fantastic education why shouldn't other children get the same opportunities".
- "There is an increasing number of children needing appropriate schools and not enough schools. This will help".
- "Enables more special needs children to benefit from a fantastic school".
- "It's a great school that could benefit more children".

 "My little one deregulated in large groups, if his class was to increase I fear more deregulations".

Q3. Do you agree that there is a local need for additional SEMH places for primary-aged pupils within Essex?

 The increased capacity proposal is critical in meeting a growing local need. This question sought to assess stakeholder agreement on expanding capacity to meet the growing demand for alternative provision.

Answer: Of the 6 respondents who completed this question, 83.3% (5 respondents) answered 'Yes' and 16.7% (1 respondent) answered "I don't know".

Q4. Can you please briefly explain the reason for your answer to the previous question?

• This open-ended question enabled respondents to provide specific feedback on the proposed capacity increase.

Answer: This section allowed respondents to share additional comments to elaborate on their answers to the previous question, providing qualitative insights into their perspectives. Of the 6 respondents who completed this question, 4 provided explanations, while 2 people skipped the question. The responses provided an overwhelming support for the proposed expansion.

Comments included:

- "There's a shortage of SEMH places in Essex".
- "There is an increasing number of children needing appropriate schools and not enough schools. This will help".
- "There are not enough school for send children anywhere".
- "Finding schools dedicated to these children in this area is very difficult, meaning these children are missing out on the education they need".

Q5. Do you think that expanding Wells Park School will have a positive impact on children and families who require this type of provision?

This question evaluated the level of support among stakeholders including future impact Wells Park School will have on children and families.

Answer: 100% of the 6 respondents answered "Yes", outlining a high level of support for the proposed

changes.

Q6. Can you please briefly explain the reason for your answer to the previous question?

• This question aimed to capture nuanced perspectives on the benefits and challenges of the

proposed expansion.

Answer: This section allowed respondents to share additional comments to elaborate on their

answers to the previous question, providing qualitative insights into their perspectives. Of the 6

respondents who completed this question, 4 provided explanations, while 2 people skipped the

question.

Comments included:

"Because it's a very good school".

"Children need an appropriate provision and wells park is excellent".

• "The school has been a very supportive god send for my grandson".

"Since my little one started this school his behaviour has calmed down a lot and his learning

has improved, all nuro-divergent children need a safe environment to learn".

Q7: In what capacity are you completing this survey?

Answer: 100% of the 6 respondents identified themselves as parents/carers of a child attending Wells

Park School.

Q8: Do you have any further comments?

Answer: 2 respondents answered, while 4 skipped. Comments included:

"Wells park is a very good school".

"Thank god for well's park school their teaching ability to these children is priceless".

Wells Park School, part of The Beckmead Trust, is a specialist residential school based in Chigwell,

Essex, providing high-quality education and care for children aged 5-11 with social, emotional and

mental health (SEMH) needs. The school currently has capacity for 56 pupils, including 40 residential

places, and is oversubscribed with 59 pupils currently attending.

In response to growing demand for specialist SEMH provision in the region, Wells Park School is

seeking approval to increase its total number of places from 56 to 70 through a DfE Significant Change

application. This increase will include an additional 11 residential places, reflecting the continued need

for safe, nurturing, and structured residential support for some of the most vulnerable children in

Essex.

This change will enable the school to broaden access to its highly specialist provision, supporting Essex

County Council in reducing the need for costly, out-of-county placements and allowing more children

to remain in their home authority. Essex County Council has secured capital funding to support this

expansion.

Wells Park School will continue to provide a therapeutic, trauma-informed learning environment that

supports pupils' social, emotional and academic development. The proposed increase in places is a

direct continuation of the school's mission to provide children with the consistency, care and

education they need to thrive.

The consultation gives key stakeholders the opportunity to engage with us and provide feedback on

the proposed changes to Wells Park School. This is an important opportunity for local residents,

families, staff, and other interested parties to share their views and help shape the future of the

school.

Wells Park currently provides specialist education and therapeutic residential care for 56 pupils aged

5–11, including 40 residential places. The school plays a vital role in the Essex SEND landscape, offering

highly personalised support to children with complex social, emotional and mental health (SEMH)

needs who may otherwise struggle to access learning in a mainstream setting.

In recent years, Essex has experienced a growing demand for specialist SEMH placements, particularly

for primary-aged children. This has been reflected in increased referrals to Wells Park and rising

pressure on available places. To meet this need, Essex County Council has worked in partnership with

The Beckmead Trust to identify sustainable options for expanding capacity at Wells Park.

The proposed change will increase the school's capacity from 56 to 70 places in September 2025,

including an uplift in residential places of 11 beds. This will allow more children to access high-quality

therapeutic education closer to home, reducing reliance on out-of-county placements and supporting

Essex's commitment to inclusive, localised SEND provision.

Funding for the necessary building works has already been secured by Essex County Council, and

construction is being delivered by the Local Authority. The works will ensure that the school

environment remains safe, nurturing, and fully equipped to meet the needs of a larger cohort without

compromising the quality of care and education.

Increased residential and day capacity:

In response to growing demand for specialist SEMH provision in the region, Wells Park School is seeking approval to increase its total number of places from 56 to 70.

This increase will include an **additional 11 residential places**, reflecting the continued need for safe, nurturing, and structured residential support for some of the most vulnerable children in Essex.

Why are we proposing this Significant Change?

Meeting Growing Demand:

Wells Park School is **oversubscribed**: currently has capacity for 56 pupils, including 40 residential places, and is oversubscribed with 59 pupils currently attending.

There is an **increasing regional need** for specialist SEMH provision for children aged **5–11** in Essex.
