### Planned Building Works at Wells Park School

I am writing to let you know about some important building works that will be taking place at Wells Park School over the coming months.

As you may be aware, part of the school site includes a RAAC affected classroom. This classroom is not currently in use and has been safely managed in line with all relevant guidance. Over the coming half term break, beginning **Monday 25th May**, this classroom will be demolished. The demolition work is planned to be completed before children return to school after the break.

This area will later be rebuilt as an extension to one of our existing classroom wings. Alongside this, we will also be expanding our residential provision by internally remodelling a section of the school. These wider works are due to begin over the summer break and are likely to continue across the next academic year, with all works expected to be completed by **summer 2027**, subject to confirmed building timeframes.

The completed project will provide the school with a range of improved facilities, including:

- New classroom space
- Intervention spaces
- Improved residential accommodation
- A dedicated youth club space
- Additional areas to support learning, wellbeing and enrichment

These developments are very positive for Wells Park and will help us continue to improve the quality of provision we offer to our children. They will also support the school's longer term development and ensure our site is better suited to the needs of our pupils.

We are very aware, however, that building works can bring some disruption. The works are being carefully planned to reduce disturbance as much as possible and to maintain the highest possible standards of safety at all times. Contractors will work within agreed safety arrangements, and children will not have access to any building areas.


