It should be noted that the school became an Academy with effect from 1st April 2019 at which point a number of changes were made – there have been no amendments to the operation of the Board as of this most recent update other than the change from a Board of Governors to a Local Governing Board. The three previous main Committees of the Board (Business Strategy Committee, Learning, Teaching and Standards Committee and Pupil Care Committee) were abolished with effect from 1st September 2018.  Parent Governors are elected by the school’s parents and carers.
 Staff Governors are elected by the school’s staff other than the Headteacher whose place is automatic from start date in post unless a Headteacher declines it.
 Associate Members are not Governors, but may sit on one of the Committees of the Governing Body, and/or the full Governing Body, usually because they have specific skills. They can be appointed for between one and four years. Our Associate Members currently do not have any voting rights.
